For full and part-time higher education courses, tuition fees are payable at the start of each academic year.

Students continuing on their programme will remain on the same tuition fee for the duration of their course. However, where students progress to a new programme, for example from HNC to HND (top-up), or from FdA/HND to BA (Hons), this is considered to be a new programme and will attract a new programme fee.

*For courses that are run over partial years (notably, 1.5 year Engineering programmes) the fees charged may vary between years of study, as detailed below.
